3. Firms are required to submit their Bids by 11:00 AM on 28-07-2022 in this office. Technical Bid will be opened on the same day at 11:30 AM. Financial Bid must include 2% Bid Security in shape of Pay Order OR Banker Cheque / Demand Draft from Commercial bank.
4. Bid received after the Due date / Time will not be accepted while Tender Documents shall NOT be sold after 28.07. 2022 @ 10.00AM
5. BID Validity should be 90 days.
6. The Procuring Agency reserves the rights to amend the Bidding Process as per BPPRA/PPRA Rules.
7. The Bidders, who download the Documents from Website, should submit the Tender Fee of Rs.5,000/- In shape of PO/DD at the time of Submission of Bid Document.
